## St Donats Community Council Points to note when considering the budget and precept:

- I have considered the Council's expenditure over the past two years and the current financial year.
- The current levy is £19.45; this is the amount that a Band D property pays to the Community Council as a proportion of its Council Tax.
- If the levy is increased by £1, that will increase the precept by £205.
- The precept in 2022/2023 was £4,085, paid in two instalments of £1,362 and one instalment of £1,361.
- Looking at the table showing budget figures, for the last three years, the Council has exceeded it income in each year.
   At the end of the financial year 31<sup>st</sup> March 2021 Council overspent by £1,213.
   At the end of the financial year 31<sup>st</sup> March 2022 Council overspent by £820.
   At the end of the projected year 31<sup>st</sup> March 2023 Council is forecast to overspend by £1,132.

So, in three years, Council have spent more than their income by a total of £3,165. This is unsustainable.

- The overspend in 2022/2023 can be largely put down to audit fees with DWA's invoice for the internal audit of £300 for the year ended 31.3.2020. It is possible that a further invoice could be received for the year 31.3.2021. However, the invoice just received from Audit Wales for additional audit work for the years 2018/2019 for £945 has drastically hit Council payments for the year 2022/2023. The invoice has not been paid yet and with Council's permission, I will appeal the invoice although I do not hold out much hope for a reduction. I have already asked for a breakdown of the costs making up the invoice total and am awaiting that before I appeal the invoice.
- Councillor Allowances as reported at the meeting of 16<sup>th</sup> November 2022, the Draft
  Independent Remuneration Report for 2023/2024 proposes that Councillors be paid
  £156 a year towards the extra household expenses (including heating, lighting,
  power and broadband) of working from home. Plus, Councils must either pay their
  Members £52 a year for the cost of office consumables required to carry out their
  role or alternatively councils must enable members to claim full reimbursement for
  the cost of their office consumables. This will place additional costs on the Council
  of £1,664 per year.
- So to summarise, the Council will need to give serious consideration to setting the
  precept for 2023/2024 and I hope that the explanation I have given will assist.
